

TREASURY BRISBANE's, "MAGIC ROUND \$1000 CASH COMPETITION" TERMS AND CONDITIONS

PROMOTIONAL PERIOD

1. The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph. (07) 3306 8888 ("Treasury"). The Promotion commences at 3:30pm Thursday 9 May 2019 and ends at 6pm Sunday 12 May 2019 ("Promotional Period"). All times listed is Australian Eastern Standard Time.
2. Eligible Entrants can enter the Promotion during individual promotional periods (each an "Entry Period") which will be advertised by the Promoter at the Venue on dates determined by the Promoter during the Promotional Period.

PARTICIPATING VENUE

3. The Promotion will be held at LiveWire Bar at The Treasury Casino Brisbane ("Venue")

PRIZES

4. The total prize pool value for the Promotion is \$4,000 comprising of 4 x individual \$1,000 cash prizes.
5. Each prize ("Prize") consists of \$1,000 in cash.

ELIGIBILITY

6. Participation in the Promotion is limited to persons who are, in venue as is the case for the duration of the Promotional Period:
 - a. 18 years of age or over;
 - b. not excluded from The Treasury Brisbane.
7. The Promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including the following entries, "Invalid Entries":
 - a. Entries that have not been completed properly
8. Invalid Entries cannot win a prize.

PARTICIPATION

9. To enter the Promotion, Eligible Entrants ("Eligible Entrants") must purchase a XXXX Gold or Iron Jack beverage from the Venue in a single transaction during a promoted Entry Period to receive an entry form ("Entry").
10. One entry form per product purchased allowed in a single transaction.
11. Purchasing of the LiveWire Footy Fanatics Combo will receive two entry forms
12. The Promoter supports the responsible service of alcohol. Eligible Entrants will only be entitled to participate in the Promotion if their participation would be consistent with the Promoter's policies or legal obligations in relation to the responsible service of alcohol. The Promotion is always subject to Treasury Brisbane's responsible service of alcohol policy. The Treasury Brisbane, reserves the right to refuse to serve a person or award an Entry if to do so would be inconsistent with Treasury Brisbane's responsible service of alcohol policy.
13. Eligible Entrants must complete all details required on the Entry and place it in the barrel ("Barrel") which will be in the Venue for the duration of each Entry Period.

DRAW

14. At a selected NRL match during each Entry Period ("NRL Match"), entries will be drawn from the Barrel for the chance to win a Prize (each a "Prize Participant") as follows (collectively a "Prize Draw"):
 - a) "Draw One" will take place at half time of the following games:
 - Titans vs Sharks match on 9/5/19
 - Sea Eagles vs Broncos on 10/5/19
 - Storm vs Eels on 11/5/19

- Storm vs Eels on 11/5/19
 - Rabbitohs vs Cowboys on 12/5/19
- where one Entry will be drawn.
15. The name of each Prize Participant noted on a drawn Entry will be announced at the Venue, following which each Prize Participant will have four (4) minutes to present themselves to the person conducting the Promotion at the Venue and provide valid identification in accordance with clause 20.
 16. If a Prize Participant doesn't present themselves within four (4) minutes of being drawn and provide valid ID, the Prize Participant forfeits their participation in the Promotion and will no longer be a Prize Participant for the purposes of these terms and conditions.
 17. If a Prize Participant forfeits pursuant to clause 16, the Promoter will draw additional entries (at either Draw One or Draw Two) until two Prize Participants who satisfy clause 15 are identified at each Prize Draw.
 18. At each Prize Draw, the name of the two Prize Participants who satisfy clause 15 will be placed onto a spinning promotional wheel ("**Promotional Wheel**").
 19. The person conducting the Promotion will spin the Promotional Wheel, ensuring a minimum of one revolution has occurred. The Prize Participant's name who is shown as being selected on the Promotional Wheel will win a Prize ("**Prize Winner**").

IDENTIFICATION REQUIREMENTS

20. To satisfy these identification requirements, a Prize Participant must present identification that is valid and acceptable to the Promoter ("**Valid ID**")

Valid ID means:

- a) A passport, Australian driver's license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to the Promoter; or
- b) One form of non-photographic identification that are valid and acceptable to the Promoter.

PRIVACY

21. The Promoter needs to collect the personal information of entrants so that the entrant can be entered into the Promotion and for the purpose of sending marketing and promotional material about the Promoter's businesses to the entrant. Without providing the Promoter with that information, the Promoter cannot enter the person in the Promotion. GENERAL

22. Except as expressly provided in these terms and conditions, Entries and Prizes cannot be redeemed for other goods and services.
23. The Promoter reserves the right to cancel or change the prizes offered under the Promotion if there are any changes to the law that would or might render the Promotion or any prizes offered under the Promotion unlawful.
24. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter. The Promoter's decisions in relation to the conduct of the Promotion are final.
25. To the extent that a situation, malfunction, or other issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, The Promoter reserves the right to (a) make a decision regarding those circumstances which is not inconsistent with these terms and conditions; and/or (b) postpone the draw(s) to a time and

- place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw(s).
26. The Promoter is not responsible for any loss, damage or injury suffered or claimed, including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter. To avoid any doubt the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
 27. The Prize Winner and any other person(s) nominated to share the Prize with the Prize Winner agrees to accept, receive and use the Prize at their own risk and will, at all times, indemnify, keep indemnified, hold harmless and release Treasury Brisbane to the full extent permitted by law from and against any and all claims, causes of action, losses, damage, liability, cost or expense (including legal expenses on a full indemnity basis), incurred by Treasury Brisbane as a result of or in connection with the Promotion and from all liability which may arise in respect of any accident, damage or injury occurring to any person or property in connection with the Prize and / or the Prize Winner.
