

CONDITIONS OF ENTRY

MOONCAKE MADNESS PROMOTION

Promoter: The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph (07) 3306 8888 ("**Treasury**").

Promotion

1. The Mooncake Madness promotion ("**Promotion**") will commence at 13:00:00 on Saturday 23 September, 2017 and conclude after the 18:30:00 prize draw on Sunday 24 September, 2017 ("**Promotion Period**"). All times are listed in Australian Eastern Standard Time.
2. The prize draw will take place on the Main Gaming Floor, Level 1 at Treasury ("**Draw Location**") 18:30:00 ("**Prize Draw**") on Sunday 24 September, 2017 ("**Draw Day**") during the Promotion Period.

Entry requirements

3. Participation in the Promotion is open to all persons who:
 - a. are 18 years of age or older;
 - b. are Members of The Star Club program operated by the Promoter and have a current membership card ("**Membership Card**");
 - c. are entitled to access the Draw Location;
 - d. are not the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
 - e. are not the subject of a Withdrawal of License (WOL) from The Star Gold Coast or Treasury Brisbane.

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as "**Eligible Entrants**" and will be entitled to enter the Promotion.

4. The Promoter reserves the right to refuse any person participation in the Promotion.

Entry into the Prize Draws

5. During the Promotion Period an Eligible Entrant can generate entries between the following times to a maximum of three (3) entries each day:
 - a. Between 13:00:00 to 18:00:00 on Saturday 23 September, 2017 to enter the Prize Draw on the Draw Day; and
 - b. Between 13:00:00 to 18:00:00 on Sunday 24 September, 2017 to enter the Prize Draw on the Draw Day (each day an "**Entry Period**").
6. Eligible Entrants can generate entries into the Prize Draws by:
 - a. playing on any compatible electronic gaming machines or electronic table games at Treasury, correctly inserting their Membership Card into the gaming machine and earning twenty (20) Tier Points during each Entry Period; and/or
 - b. on any rated table game or electronic table game play, excluding rebate play, the Eligible Entrant providing their Membership Card to the table game dealer upon commencement of play within the Entry Period and earning twenty (20) Tier Points during an Entry Period. The Eligible Entrant's table game play will be entered via the Konami Casino Management System during the Entry Period. An Eligible Entrant's session of table play ends when the table game dealer swipes their Membership Card to finish off their play (failure to do this may result in an entry not being available for inclusion in any Prize Draw). It is the Eligible Entrants responsibility to request the table game dealer to finish off their session of play so that their Entry may be included in the relevant Prize Draw. No responsibility is accepted by the Promoter in this respect whatsoever.

7. Eligible Entrants who have earned entries in accordance with **Conditions 5 and 6** must print their entries (each a "**Entry Ticket**") at any Member Kiosk during an Entry Period. Eligible Entrants may present their Entry Tickets at the collection desk located at the Draw Location to collect their complimentary mooncake (limit of 500 mooncakes to be distributed during each Entry Period). Entry Tickets must be placed in the barrel from 13:00:00 on Saturday 23 September, 2017 up until one (1) minute prior to the Prize Draw. The barrel is located at the Draw Location.

Prize Draws

8. One (1) Prize Draw will be conducted on the Draw Day from all valid Entry Tickets submitted in accordance with **Condition 7**.
9. At the Prize Draw, the first name and membership number of one (1) Eligible Entrants will be drawn by a representative of the Promoter and will be announced at the Draw Location and throughout Treasury ("**Selected Member**").
10. The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of Treasury.

Present at the Prize Draw

11. To be considered "present at the Prize Draw" and therefore eligible to claim a prize, the Selected Member must present themselves to a representative of the Promoter at the VIP Services Desk, The Star Club Desk or at the Draw Location within three (3) minutes of their name being announced and confirm their identity in accordance with **Conditions 18 or 19**.
12. If a Selected Member has presented themselves at the VIP Services Desk or The Star Club Desk in accordance with **Condition 11**, the representative of the Promoter will inform the promotions host at the Draw Location that the Selected Member has presented themselves and such Selected Member will have five (5) minutes to make their way to the Draw Location and confirm their identity in accordance with **Conditions 18 or 19**. Selected Members are not permitted to send a proxy to claim a prize. The Promoter reserves the right in its absolute discretion to extend the time limit set out within this clause if the Promoter forms the reasonable view that a Selected Member will be physically unable to comply with such time limit due to incapacity or any other such impairment. It is the responsibility of the Selected Member to request such time extension from the representative of the Promoter before making their way to the Draw Location. Time Extensions will not be granted retrospectively.
13. If a Selected Member does not satisfy **Condition 11 or 12** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Selected Member who satisfy the requirements of these Conditions of Entry (including by being "present at the Prize Draw") is drawn at the Prize Draw.

Prizes

14. At the Prize Draw the Selected Member will, subject to compliance with these Conditions of Entry, receive \$5,000 cash prize ("**Winner**").
15. The Winner will receive their prize after their identity has been confirmed in accordance with **Conditions 18 or 19**.
16. The Winner may choose to take their prize in cash or a cheque or a combination of both from the Promoter.
17. The total prize pool for this Promotion is \$5,000 cash ("**Prize Pool**").

Identification

18. A Selected Member must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form

- of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
19. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Selected Member is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

General

20. Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the *Corporations Act 2001*) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises, but is not limited to the businesses of The Star Sydney, The Star Gold Coast and Treasury Brisbane.
21. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the Winner claiming that prize.
22. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter.
23. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
24. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions.
25. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
26. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
27. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
28. Winners may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Winner. The names of Winners will not be published without their consent except as announced at the Draw Location.
