

## CONDITIONS OF ENTRY

### QUEEN'S BIRTHDAY JACKPOD CHALLENGE PROMOTION

**Promoter:** Jupiters Limited ABN 78 010 741 045 trading as Treasury Casino & Hotel Brisbane, 159 William Street, Brisbane QLD 4001 ph (07) 3306 8888 ("**Treasury**").

#### Promotion Period

1. The Queen's Birthday JackPod Challenge promotion ("**Promotion**") will be held at Treasury commencing at 08:00:00 on Sunday 2 October, 2016 and concluding at the end of the final heat at 17:00:00 on Sunday 2 October, 2016 ("**Promotion Period**"). All times are listed in Australian Eastern Standard Time.
2. A total of five (5) draws will be held on the Main Gaming Floor, Level 1 at Treasury ("**Draw Location**") during the Promotion Period. Draws will be held at 10:30:00, 11:30:00, 12:30:00, 13:30:00 and 14:30:00 (each a "**Draw**") during the Promotion Period.
3. The Promotion will consist of:
  - a. Qualifying heats will start once all present Eligible Members are found in accordance to **Condition 10** and **11** at each Draw during the Promotion Period (each a "**Qualifying Heat**") at the Draw Location;
  - b. The final heat will be held at 17:00:00 during the Promotion Period ("**Final Heat**") in the Draw Location.

#### Entry requirements

4. Participation in the Promotion is open to all persons who:
  - a. are 18 years of age or older;
  - b. are members of the Absolute Rewards loyalty program operated by the Promoter and who have a current Pearl Tier Absolute Rewards Membership card ("**Membership Card**").
  - c. are entitled to access the Promotion Location;
  - d. are not the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
  - e. are not the subject of a Withdrawal of Licence (WOL) from Jupiters Hotel & Casino Gold Coast, Treasury Casino & Hotel Brisbane or The Star Sydney.

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as "**Eligible Members**" and will be entitled to participate in the Promotion.

5. The Promoter reserves the right to refuse any person entry in the Promotion at any time.

#### Entry into the Draw

6. Eligible Members will be eligible for one (1) entry ("**Entry**") for every one (1) Casino Dollar earned on compatible electronic gaming machines, Vegas Star and Rapid Fusion between 08:00:00 to 14:15:00 ("**Entry Period**") during the Promotion Period.
7. Eligible Members who have earned Entries will be automatically entered into the Draws via the Konami Casino Management System. Only Casino Dollars earned through electronic gaming machines, Vegas Star and Rapid Fusion during the Entry Period will be automatically converted to Entries into the relevant Draw. Casino Dollars awarded as part of any other promotion or offer will not be included for the purposes of calculating Entries for inclusion into a Draw.
8. Each Entry will be automatically entered and allocated a unique individual entry number using the Konami Casino Management System ("**KCMS**").

#### Entry into the Qualifying Heat

9. The Promoter will perform the Draw with KCMS to randomly select five (5) Entries from all Entries in that Draw to enter the Qualifying Heat.

10. At each Draw, the first name and membership number of the Eligible Member identified on the first correctly drawn and validly entered Entry will be announced at the Draw Location (each a “**Qualifier**”). Each Qualifier may only be drawn once during the Promotion Period.
11. Each Qualifier must be “present at the relevant Draw” in accordance with **Condition 14** to be eligible to entry each Qualifying Heat. If a Qualifier is not “present at the Draw”, **Condition 15** will apply and there will be a further Draws to find an Eligible Member who satisfies these conditions.
12. A Qualifier can nominate a proxy to compete on their behalf. The proxy cannot be affiliated with the Promoter as defined in **Condition 35**. Any prizes won will be awarded to the Qualifier and not the proxy.
13. The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of Treasury.

#### **Present at the Draws**

14. To be deemed “present at the Draws” Qualifiers must present themselves to a Treasury representative at the Draw Location, Absolute Rewards Desk Ground Floor or the VIP Services Desk Level 2, within three (3) minutes of their name being announced and provide suitable identification in accordance with **Conditions 33 or 34** when presenting themselves. If the Qualifier has presented themselves to a representative of the Promoter, at a location specified above other than the Draw Location, the Treasury representative will inform the promotions host at the Draw Location that the Qualifier has presented themselves and such Qualifier will have five (5) minutes to present him/herself to the Promoter at the Draw Location. Qualifiers that are “present at the Draw” will be eligible to participate in the Qualifying Heat. The Promoter reserves the right in its absolute discretion to extend the time limit set out within this clause if the Promoter forms the reasonable view that a Qualifier will be physically unable to comply with such time limit due to incapacity or any other such impairment. It is the responsibility of the Qualifier to request such time extension from the representative of the Promoter before making their way to the Draw Location. Time Extensions will not be granted retrospectively.
15. If a Qualifier does not satisfy **Condition 14** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Qualifier who satisfy the requirements of these Conditions of Entry (including by being “present at the Draw.”) is drawn for each of the relevant Draw.

#### **Participate in the Qualifying Heat**

16. After each Draw, the Qualifier will be required to present themselves at the Tournament Location where they will, subject to compliance with these Conditions of Entry, be allocated one (1) of five (5) JackPod units (“**Units**”) in the order in which they were selected.
17. The five (5) Qualifiers will register a score (“**Score**”) by playing on their allocated Unit for a period of sixty (60) seconds.
18. The Qualifier with the highest Score at conclusion of the Qualifying Heat will proceed to the Final Heat (each a **Finalist**)
19. A Finalist can nominate a proxy to compete on their behalf. The proxy cannot be affiliated with the Promoter as defined in **Condition 35**. Any prizes won will be awarded to the Finalist and not the proxy.
20. Each of the four (4) Qualifiers who did not qualify through to the Final Heat will receive \$20 Casino Dollars. Each Qualifier will have their Casino Dollars added to their Casino Dollar balance by a representative of the Promoter. These Casino Dollars are not transferable. Casino Dollars may become unavailable due to technical difficulties outside of our control.
21. Qualifiers can decline to participate in the Qualifying Heat and take the \$20 Casino Dollars prize. The remaining Qualifiers will compete in accordance with **Condition 17 and 18**

#### **Play-Offs**

22. If any two (2) or more Qualifiers have a tied Score at the conclusion of the Qualifying Heat, which will affect the allocation of their place in the Final Heat, there will be a sixty (60) second play-off on an allocated Unit between these two (2) or more Qualifiers (a “**Play-Off**”). The Qualifier who was drawn first will select their Unit first in a Play-Off.

23. The Qualifier who achieves the highest Score in a Play-Off will proceed to the Final Heat. If any two (2) or more Qualifiers have a tied Score as the result of a Play-Off, further Play-Offs will be held between those Qualifiers with a tied Score until those Qualifiers register different Scores. The Score achieved by the Qualifier in a Play-Off will only be used to determine the ranking of the Scores of the Qualifiers as between themselves for entry into the Final Heat.

### Final Heat

24. Finalists will be asked to return to the Draw Location at 17:00:00 where they will, subject to compliance with these Conditions of Entry be allocated one of five (5) Units in the order in which they were selected.
25. Should a Finalist not return to the Draw Location by 17:10:00 during the Tournament Period, the Final Heat will take place with the present Finalists and any unclaimed prizes will be split amongst the present Finalists.
26. The five (5) Finalists will register a score ("**Score**") by playing on their allocated Unit for a period of sixty (60) seconds.
27. If two or more Finalists have a tied Score at the conclusion of the Final Heat, there will be a sixty (60) second Play-Off in accordance with **Condition 22 and 23** to determine the ranking of the Scores of those Finalists.
28. The winner of the Final Heat will be the Finalist with the highest Score after sixty (60) seconds of play in the Final Heat or, if required, a Play-Off in accordance with **condition 26**. The four (4) remaining Finalists will be the runners-up (each a "**Runner-Up**").

### Prizes

29. Prizes will be awarded according to the ranking of the Finalist's Scores:

Score Rank	Prize
First place	\$7,000 cash
Second to fifth Runners-Up	\$250 Casino Dollars

(each a "**Prize**").

30. Each Runner-Up will have their Prize added to their Casino Dollar balance by a representative of the Promoter. Prizes are not transferable. Casino Dollars may become unavailable due to technical difficulties outside of our control.
31. The first place winner may choose to take their Prize in cash or a cheque or a combination of both from the Promoter

### Prize Pool

32. The total prize pool for this Promotion is \$8,000 made up of \$7,000 cash and \$1,000 Casino Dollars. ("**Prize Pool**").

### Identification

33. An Eligible Members must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter. An Eligible Member must also produce their Membership Card to confirm their eligibility to win a prize and to participate in the Qualifying Heat.
34. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of an Eligible Member is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

### General

35. Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the Corporations Act 2001) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment

Group comprises, but is not limited to the businesses of The Star, Jupiters Hotel & Casino and Treasury Casino & Hotel.

36. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the Winner claiming that Prize.
37. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
38. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of, and at the absolute discretion of, the Promoter.
39. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
40. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
41. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the Kiosk, the Promoter reserves the right to adopt a manual process of generating Entries.
42. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
43. Winners may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Selected Members. The names of Selected Members will not be published without their consent except as announced at the Draw Location.
44. Participation in the Promotion indicates acceptance of the terms and conditions governing the Promotion. These terms and conditions will be available at the Absolute Rewards Desk Ground Floor and the VIP Desk Level 2 throughout the Promotion Period.
45. By participating in this Promotion, each entrant's Entry/Entries becomes the property of the Promoter and may be used for the Promoter's business analysis and marketing purposes in accordance with the Promoter's privacy statement which can be viewed at <http://www.treasurybrisbane.com.au>. Privacy law allows entrants to access their personal information held by the Promoter in certain circumstances. Failure to supply the personal information requested may result in an entry being deemed invalid.
46. It is the responsibility of all winners to determine if they have won a Prize in this Promotion at the Absolute Rewards Desk or the VIP Desk. Whilst Treasury will use all reasonable endeavours to contact Winners, it is the Winner's ultimate responsibility to claim their prize.
