

CONDITIONS OF ENTRY

PRESTIGE TIME PROMOTION

Promoter: The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph (07) 3306 8888 ("**Treasury**").

Promotion

1. The Prestige Time promotion ("**Promotion**") will commence at 00:15:00 on Tuesday 1 May 2018 and conclude after the 16:00:00 prize draw on Saturday 30 June 2018 ("**Promotion Period**"). All times are listed in Australian Eastern Standard Time.
2. Prize draws ("**Prize Draw**") will take place in The Suite, Level 2 at Treasury ("**Draw Location**") at 16:00:00 on the 27 May and 30 June 2018 (each a "**Draw Day**"). A total of two (2) Prize Draws will be conducted during the Promotion Period.

Entry requirements

3. Participation in the Promotion is open to all persons who:
 - a. are 18 years of age or older;
 - b. are Members of The Star Club program operated by the Promoter and have a current Prestige Gold membership card or higher ("**Membership Card**");
 - c. are entitled to access the Draw Location;
 - d. are not the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
 - e. are not the subject of a Withdrawal of License (WOL) from The Star Gold Coast or Treasury Brisbane.

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as "**Eligible Entrants**" and will be entitled to enter the Promotion.

4. The Promoter reserves the right to refuse any person participation in the Promotion.

Prize Draw Earning Periods

5. During the Promotion Period, an Eligible Entrant can generate entries between the following times (each an "**Entry**"):
 - a. From 00:15:00 to 23:59:00 on the 1 to 26 May 2018 and from 00:15:00 to 15:45:00 on the 27 May 2018 to eligible for the Prize Draw on Sunday 27 May 2018; and
 - b. From 00:15:00 to 23:59:00 on the 1 to 29 June 2018 and from 00:15:00 to 15:45:00 on the 30 June 2018 to eligible for the Prize Draw on Saturday 30 June 2018 (each day an "**Entry Period**").

Earning Requirements

6. Eligible Entrants can generate Entries into the Prize Draws by:
 - a. playing on any compatible electronic gaming machines or electronic table games at Treasury, correctly inserting their Membership Card into the gaming machine and earning one-hundred (100) Tier Points during each Entry Period; and/or
 - b. on any rated table game, excluding rebate play, the Eligible Entrant providing their Membership Card to the table game croupier upon commencement of play within the Entry Period and earning one-hundred (100) Tier Points. The Eligible Entrant's table game play will be entered via the Konami Casino Management System during the Entry Period. An Eligible Entrant's session of table play

ends when the table game croupier swipes their Membership Card to finish off their play (failure to do this may result in an Entry not being available for inclusion in any Prize Draw). It is the Eligible Entrants responsibility to request the table game croupier to finish off their session of play so that their Entry may be included in the relevant Prize Draw. No responsibility is accepted by the Promoter in this respect whatsoever.

7. Eligible Entrants who have earned Entries in accordance with **Conditions 6** will be automatically entered into the relevant Prize Draw via the Konami Casino Management System.

Prize Draws

8. One (1) Prize Draw will be conducted from all valid Entries submitted in accordance with **Condition 7** in each relevant Draw Day during the Promotion Period.
9. At the Prize Draw, the first name and Membership Card number of one (1) Eligible Entrant will be drawn by a representative of the Promoter and will be announced at the Draw Location and throughout Treasury ("**Winner**").
10. If a Winner is present at the relevant Prize Draw and therefore able to claim their prize, the Winner must present themselves as per **Condition 11**. If a Winner is "not present at the relevant Prize Draw", **Condition 12** will apply.

Present and non-present at the Prize Draws

11. If a Winner is present at a relevant Prize Draw and therefore able to claim their prize, the Winner must present themselves to a representative of the Promoter at The Star Club Desk Ground Floor, VIP Services Desk Level 2 or at the Draw Location and confirm their identity in accordance with **Conditions 15 or 16** when presenting themselves. The Winner is not permitted to send a proxy to claim a prize.
12. If a Winner is not present at a Prize Draw, the Winner will be notified of their win by phone, email or mail in accordance with their membership details held by the Promoter. Winners will receive their prize, once they have presented to the Promoter. Winners may be asked to provide a valid acceptable identification in accordance with **Condition 15 or 16** before claiming their prize.

Prizes

13. The Winners will, subject to compliance with these Conditions of Entry, have the opportunity to choose one (1) of the following prizes (each a "**Prize**"):

 - b. Penfolds Grange 2010 Shiraz Magnum 1.5lt valued at \$2,500.

Prize Pool

14. The total prize pool for this Promotion is \$5,000 in Prizes ("**Prize Pool**").

Identification

15. A winner must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
16. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

General

17. Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the *Corporations Act 2001*) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises, but is not limited to the businesses of The Star Sydney, The Star Gold Coast and Treasury Brisbane.
18. The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of Treasury.
19. Casino Dollars may become unavailable due to technical difficulties outside of the Promoter's control.
20. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Prizes are not transferable. Any tax liability or implication which attaches to a prize is the responsibility of the Winner claiming that prize.
21. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter.

To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions.
24. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
25. The Promoter accepts no responsibility for late or non-received Entries. The Promoter does not guarantee the continuous or fault-free operation of the Entry processes, including Entry validating and receipting processes, during the Promotion.
26. Any entrant who tampers, or attempts to tamper, with the Entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an Entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.

Participation in any such publicity or advertising is at the sole discretion of the relevant Winner.
