

CONDITIONS OF ENTRY

SHOW STOPPER SLOTS TOURNAMENT

Promoter: The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph. (07) 3306 8888 ("**Treasury**").

Promotion Period

1. The Show Stopper Slots Tournament ("**Tournament**") will be held at Treasury commencing at 11:00:00 on Wednesday 16 August, 2017 and concluding at the end of the final heat at 15:15:00 on Wednesday 16 August, 2017 ("**Tournament Period**"). All times are listed in Australian Eastern Standard Time.
2. A total of ten (10) draws will be held in The Suite, level 2 at Treasury ("**Draw Location**") during the Tournament Period. Draws will be held at 13:00:00, 13:15:00, 13:30:00, 13:45:00, 14:00:00, 14:15:00, 14:30:00, 14:45:00, 15:00:00 and 15:15:00 (each a "**Draw**").
3. The Tournament will consist of heats and will start once all present Eligible Members are found in accordance to **Condition 11** and **12** at each Draw during the Tournament Period (each a "**Heat**") at the Draw Location.

Entry requirements

4. Participation in the Tournament is open to all persons who:
 - a. are 18 years of age or older;
 - b. are members of The Star Club loyalty program operated by the Promoter and who have a current Gold membership card or higher ("**Membership Card**").
 - c. are entitled to access the Promotion Location;
 - d. are not the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
 - e. are not the subject of a Withdrawal of Licence (WOL) from The Star Gold Coast or Treasury Brisbane.

People who meet the above conditions and continue to satisfy the conditions during the Tournament Period are referred to as "**Eligible Members**" and will be entitled to participate in the Tournament.

5. The Promoter reserves the right to refuse any person entry in the Tournament at any time.

Entry into the Draw

6. During the Promotion Period an Eligible Entrant can generate one (1) entry ("**Entry**") between 11:00:00 to 15:14:00 during the Tournament Period ("**Entry Period**").
7. The Promoter reserves the right to manually issue Eligible Member with an Entry. Lost, stolen or misplaced Entries may not be replaced.
8. An Eligible Entrant can generate an entry into the Prize Draws by:
 - a. playing on any compatible electronic gaming machines or electronic table games at Treasury, correctly inserting their Membership Card into the gaming machine during each Entry Period; and/or
 - b. on any rated table game or electronic table game play, excluding rebate play, the Eligible Entrant providing their Membership Card to the table game dealer upon commencement of play within the Entry Period. The Eligible Entrant's table game play will be entered via the Konami Casino Management System during the Entry Period. An Eligible Entrant's session of table play ends when the table game dealer swipes their Membership Card to finish off their play (failure to do this may result in an entry not being available for inclusion in any Draw). It is the Eligible Entrants responsibility to request the table game dealer to finish off their session of play so that their Entry may be included in the relevant Draw. No responsibility is accepted by the Promoter in this respect whatsoever.
9. Eligible Entrants who have earned entries in accordance with **Conditions 6 and 8** must print their entries at any Member Kiosk during an Entry Period ("**Entry Ticket**"). Entry Tickets are to be placed in the barrel from

11:00:00 up until one (1) minute prior to each Draw during the Tournament Period. The barrel is located at the Draw Location.

Entry into the Heat

10. Draws will be conducted from all valid Entries submitted in accordance with **Condition 9**.
11. At each draw, the first name and membership number of ten (10) Eligible Members identified on the first correctly drawn and validly entered Entries will be announced at the Draw Location (each a "**Contestant**").
12. Each Contestant must be "present at the relevant Draw" in accordance with **Condition 15** to be eligible to compete in a Heat. If a Contestant is not "present at the draw", **Condition 16** will apply.
13. A Contestant can nominate a proxy to compete on their behalf. The proxy cannot be affiliated with the Promoter as defined in **Condition 28**. Any prizes won will be awarded to the Contestant and not the proxy.
14. The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of Treasury.

Present at the Draws

15. To be deemed "present at the Draws" Eligible Members must present themselves to a Treasury representative at the Draw Location, The Star Club Desk Ground Floor or the VIP Services Desk Level 2 within three (3) minutes of their name being announced and provide suitable identification in accordance with **Conditions 26 or 27** when presenting themselves. If the Contestant has presented themselves to a representative of the Promoter, at a location specified above other than the Draw Location, the Treasury representative will inform the promotions host at the Draw Location that the Contestant has presented themselves and such Contestant will have five (5) minutes to present him/herself to the Promoter at the Draw Location. Contestants that are "present at the Draw" will be eligible to participate in the Heat. The Promoter reserves the right in its absolute discretion to extend the time limit set out within this clause if the Promoter forms the reasonable view that a Contestant will be physically unable to comply with such time limit due to incapacity or any other such impairment. It is the responsibility of the Contestant to request such time extension from the representative of the Promoter before making their way to the Draw Location. Time Extensions will not be granted retrospectively.
16. If a Contestant does not satisfy **Condition 15** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Contestant who satisfy the requirements of these Conditions of Entry (including by being "present at the Draw.") is drawn for each of the relevant Draw.

Participate in the Heat

17. After each Draw, the Contestant will be required to present themselves at the Draw Location where they will, subject to compliance with these Conditions of Entry, be allocated one (1) of ten (10) Slots Machines ("**Tournament Machine**") in the order in which they were selected.
18. The ten (10) Contestants will register a score ("**Score**") by playing on their allocated Tournament Machine for a period of sixty (60) seconds.
19. If two or more Contestants have a tied Score at the conclusion of the Heat, there will be a sixty (60) second Play-Off in accordance with **Condition 20 and 21** to determine the ranking of the Scores of those Contestants.

Play-Offs

20. If any two (2) or more Contestants have a tied Score after the Heat, which will affect the allocation of their prize, there will be a sixty (60) second play-off on an allocated Tournament Machine between these two (2) or more Contestants (a "**Play-Off**"). The Contestant who was drawn first will select their Tournament Machine first in a Play-Off.
21. The Contestant who achieves the highest Score in a Play-Off will win the allocated prize. If any two (2) or more Contestants have a tied Score as the result of a Play-Off, further Play-Offs will be held between those

Contestants with a tied Score until those Contestants register different Scores. The Score achieved by the Contestant in a Play-Off will only be used to determine the ranking of the Scores of the Contestants as between themselves for their prize allocation.

Prizes

22. Prizes will be awarded according to the ranking of the Contestant's Scores after each Heat:

Score Rank	Prize
First place	\$100 Casino Dollars
Second and third place	\$50 Casino Dollars
Fourth to tenth place	\$10 Bite Voucher

(each a "Prize").

23. Each Contestant will have their Casino Dollar Prize added to their Casino Dollar balance by a representative of the Promoter. Prizes are not transferable. Casino Dollars may become unavailable due to technical difficulties outside of our control.

24. Bite Voucher Prizes are valid until Friday 18 August, 2017. Additional terms may also apply; these terms will be printed on the voucher.

Prize Pool

25. The total prize pool for this Tournament is \$2,700 in Casino Dollars and prizes. ("Prize Pool").

Identification

26. An Eligible Members must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter. An Eligible Member must also produce their Membership Card to confirm their eligibility to win a prize and to participate in the Qualifying Heat.

27. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of an Eligible Member is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

General

28. Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the Corporations Act 2001) and their immediate families are not eligible to participate in this Tournament. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises, but is not limited to the businesses of The Star Sydney, The Star Gold Coast and Treasury Brisbane.

29. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the Winner claiming that Prize.

30. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Tournament or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.

31. Conduct of the entire Tournament, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of, and at the absolute discretion of, the Promoter.

32. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
33. While the Promoter intends to conduct the Tournament as offered, the Promoter reserves the right to cancel or change the Tournament or a prize offered in the Tournament if it can no longer continue the Tournament or offer a prize due to circumstances outside the Promoter's control.
34. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Tournament. In the event of any technical difficulties with the Kiosk, the Promoter reserves the right to adopt a manual process of generating Entries.
35. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
36. Winners may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Selected Members. The names of Selected Members will not be published without their consent except as announced at the Draw Location.
37. Participation in the Tournament indicates acceptance of the terms and conditions governing the Tournament. These terms and conditions will be available at The Star Club Desk and the VIP Services Desk throughout the Tournament Period.
38. By participating in this Tournament, each entrant's Entry/Entries becomes the property of the Promoter and may be used for the Promoter's business analysis and marketing purposes in accordance with the Promoter's privacy statement which can be viewed at <http://www.treasurybrisbane.com.au>. Privacy law allows entrants to access their personal information held by the Promoter in certain circumstances. Failure to supply the personal information requested may result in an entry being deemed invalid.
39. It is the responsibility of all winners to determine if they have won a Prize in this Tournament at The Star Club Desk or the VIP Services Desk. Whilst Treasury will use all reasonable endeavours to contact Winners, it is the Winner's ultimate responsibility to claim their prize.
