

## CONDITIONS OF ENTRY

### TABLE TRIFECTA PROMOTION

**Promoter:** The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Casino & Hotel, 159 William Street, Brisbane QLD 4001 ph (07) 3306 8888 ("**Treasury**").

#### Promotion

1. The Table Trifecta promotion ("**Promotion**") will commence at 00:00:00 on Monday 5 March 2018 and conclude at the conclusion of the 15:00:00 prize draw on Sunday 25 March 2018 ("**Promotion Period**"). All times are listed in Australian Eastern Standard Time.
2. Prize draws will take place in The Suite Table Games Room, level 2 at Treasury ("**Draw Location**") at 15:00:00 (each a "**Prize Draw**") on Sunday 11, 18 and 25 March 2018 (each a "**Draw Day**") during the Promotion Period.

#### Entry requirements

3. Participation in the Promotion is open to all persons who:
  - a. are 18 years of age or older;
  - b. are Members of The Star Club program operated by the Promoter and have a current Gold or higher membership card (each a "**Membership Card**");
  - c. are entitled to access the Draw Location;
  - d. are not the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
  - e. are not the subject of a Withdrawal of License (WOL) from The Star Gold Coast or Treasury Brisbane.

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as "**Eligible Entrants**" and will be entitled to enter the Promotion.

4. The Promoter reserves the right to refuse any person participation in the Promotion.

#### Entry Period

5. During the Promotion Period, an Eligible Entrant can generate entry tickets between the following times (each an "**Entry Ticket**"):
  - a. From 00:00:01 Monday 5 March up until 14:59:00 Sunday 11 March 2018 to be eligible for the Prize Draw on the 11 March 2018 Draw Day;
  - b. From 15:00:01 Sunday 11 March up until 14:59:00 Sunday 18 March 2018 to be eligible for the Prize Draw on the 18 March 2018 Draw Day; and
  - c. From 15:00:01 Sunday 18 March up until 14:59:00 Sunday 25 March 2018 to be eligible for the Prize Draw on the 25 March 2018 Draw Day (each week an "**Entry Period**").
6. Eligible Entrants can generate an Entry Ticket into a Prize Draw by playing on Blackjack, Pontoon, Mini Baccarat or Roulette located in the Private Gaming Rooms, Level 2, the Eligible Entrant providing their Membership Card to the table game dealer upon commencement of play within the Entry Period and if the Eligible Entrant wins on the following:
  - a. Blackjack winning bet 30 to 1 Perfect Pair;
  - b. Pontoon winning bet 25 to 1 Perfect Pair;
  - c. Mini Baccarat winning Dragon Bonus bet 30 to 1 or 10 to 1;
  - d. Mini Baccarat winning any Pairs; or
  - e. Roulette winning inside layout bet on number 8 (each a "**Winning Bet**").

7. Eligible Entrants who have earned Entries in accordance with **Condition 5 and 6** can request an Entry Ticket from any Gaming Operations Supervisor during the Promotion Period. Entry Tickets are to be completed including full name and Membership number and placed in the barrel located at the Draw Location up until one (1) minute prior to each relevant Prize Draw on Draw Days during the Promotion Period.
8. On completion of each Prize Draw, all remaining Entry Tickets in the barrel will be discarded.

### Prize Draws

9. At each Draw Day one (1) Prize Draw will be conducted from all valid Entries submitted in accordance with **Condition 7** during the Promotion Period.
10. At each Prize Draw on each Draw Day, fifteen (15) Eligible Entrants will be randomly drawn from the barrel (each a **"Selected Member"**) and (subject to compliance with these Conditions of Entry) those Selected Members will be eligible to win a major prize as detailed in **Condition 14**. Selected Members do not have to be present at the Prize Draw to win a prize. If a Selected Member is present at the Prize Draw they will be eligible to receive a bonus prize as detailed in **Condition 15**. ### Present at the Prize Draws

### Bonus Prizes

15. Each Selected Member who satisfies these Conditions of entry and who are present at the Prize Draw will have the opportunity to spin the prize wheel to determine their bonus prize (each a **"Present Winner"**). The prize wheel must make a minimum of one full rotation to be deemed a valid spin. Bonus prizes include:
  - a. One prize of \$5,000 Casino Dollars;
  - b. One prize of \$1,000 Casino Dollars;

- c. One prize of \$500 Casino Dollars;
- d. Three prizes of \$400 Casino Dollars;

### Prize Pool

17. The maximum total prize pool for this Promotion is \$252,738 in Casino Dollars and prizes based on all Selected Members being present and the highest Bonus Prize being won by each Selected Member (**"Prize Pool"**).

### Identification

18. A Selected Member must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.

### General

Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the *Corporations Act 2001*) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises, but is not limited to the businesses of The Star Sydney, The Star Gold Coast and Treasury Brisbane.
21. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the Selected Member claiming that prize.
22. 25. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.

26. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
