CONDITIONS OF ENTRY

VIP MYSTERY SHOWCASE PROMOTION

Promotion Period

- 1. The VIP Mystery Showcase promotion ("**Promotion**") will commence at 20:00:00 on Wednesday 4 April 2018 and conclude at 21:00:00 on Wednesday 25 April 2018 ("**Promotion Period**"). All times are listed in Australian Eastern Standard Time.
- 2. Random selection draws will take place on the Main Gaming Floor level 1, Private Gaming Rooms level 2 and Ground Floor at Treasury ("**Draw Locations**") between 20:00:00 and 21:00:00 on the 4, 11, 18 and 25 April 2018 (each day a "**Random Selection Period**"). A total of twelve (12) random selection draws will be conducted during the Promotion Period (each a "**Random Selection Draw**").

- 4. Participation in the Promotion is open to all persons who:
 - a) are 18 years of age or older;
 - b) are members of The Star Club loyalty program operated by the Promoter and who have a current Platinum membership card or higher ("**Membership Card**");
 - c) are entitled to access the Draw Location;
 - d) are not the subject of an exclusion direction or self exclusion order pursuant to the Casino Control Act 1982 (Qld); and
 - e) are not the subject of a Withdrawal of Licence (WOL) from The Star Gold Coast or Treasury Brisbane.

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as an "**Eligible Entrant**" and will be entitled to participate in the Promotion.

5. The Promoter reserves the right to refuse any person entry in the Promotion at any time.

Entry into the Random Selection Draws
