

# 'WIN THE ULTIMATE UBET STRADBROKE DAY EXPERIENCE' COMPETITION / TERMS & CONDITIONS

## Conditions of Entry

**Promoter:** The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph. (07) 3306 8888 ("**Treasury**").

## Promotion

1. The promotion commences at 9.30am AEST on Saturday 26 May, 2018 and closes at 5.00pm AEST on Saturday 26 May, 2018 ("**Promotion Period**").
2. The Promotion will be conducted on the Treasury Instagram and Facebook Page managed by the Promoter.
3. One (1) Prize Draw ("**Prize Draw**") will be held on Monday 28 May, 2018 at approximately 3.00pm. One (1) winner ("**Winner**") will be judged from entries submitted during the competition period ("**Promotion Period**"). During the Promotion Period one (1) Prize Winner will be announced. The Prize Winner will be announced on the Treasury Brisbane Facebook and Instagram page at approximately 3.00pm on Monday 28 May, 2018.
4. The Prize Draw will be held at Treasury Brisbane Marketing Office, 159 William Street, Brisbane QLD 4000 ("**Draw Location**").

## Entry requirements

5. Participation in the Promotion is open to all persons who:
  - a. are 18 years of age or older;
  - b. must be contactable via Facebook or Instagram messaging;
  - c. are not the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld); and
  - d. are not the subject of a Withdrawal of Licence (WOL) from The Star Gold Coast or Treasury Brisbane.
6. People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as an "**Eligible Entrant**" and will be entitled to enter the Promotion.

## Entry into the promotion
