TERMS & CONDITIONS

Conditions of Entry

1. **Promoter:** The Promoter is The Star Entertainment QLD Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph. (07) 3306 8888 ("**Treasury**").

Promotion

2. The promotion commences at 5.00pm AEST Wednesday 6 February, 2019 and closes at 5pm AEST on Friday 8 March, 2019 ("**Promotion Period**").
3. The Promotion will be conducted at Treasury Hotel Courtyard at Treasury Hotel, 130 William Street, Brisbane Q 4000 and will be managed by the Promoter ("**Promotion Location**").
4. One (1) Prize Draw ("**Prize Draw**") will be held during the Promotion Period ("**Draw Day**") at approximately 7.00pm on Friday 8 March, 2019.
5. The Prize Winner ("**Prize Winner**") in the Prize Draw ("**Prize Draw**") will be chosen by random selection from all eligible entries and announced at the Promotion Location ("**Draw Location**").

Entry requirements

6. Participation in the Promotion is open to all persons who:
 - a. are 18 years of age or older;
 - b. are not the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld); and
 - c. are not the subject of a Withdrawal of Licence (WOL) from The Star Gold Coast or Treasury Brisbane
