

Terms and Conditions

Magic Weekend Wristband Draw – May 2024

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Treasury Brisbane, 130 William Street, Brisbane City, Queensland 4000, (07) 3306 8888 (the “Promoter”).
Item 2: Promotion	Magic Weekend Wristband Draw – May 2024 (the “Promotion”).
Item 3: Participating Property	Treasury Brisbane
Item 4: Promotion Period	<p>The Promotion will commence at 1.00pm on Saturday 18 May 2024, and end at 2.00pm.</p> <p>The draw of the winning tickets (2) will take place at 2:15pm.</p> <p>All times are listed in Australian Eastern Standard Time.</p>
Item 5: Entry Requirement	<p>Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion.</p> <p>People who meet these conditions and continue to satisfy the conditions during the Promotion Period are referred to as “Eligible Entrant/s” and will be entitled to enter the Promotion.</p> <p>The Promoter reserves the right to refuse any person participating in the Promotion at any time.</p>
Item 6: Entry Into Draws	<p>Eligible Entrants will be issued one (1) wristband, between 1.00pm and 2.00pm on the Draw Day at the Draw Location – LiveWire 24/7 Sports Bar.</p> <p>A maximum of one (1) Wristband Entry can be taken per Draw Day.</p> <p>The Eligible Entrants will need to place the wristband onto their own wrist, detach the entry ticket from the wristband (“Entry Ticket”) and place the Entry Ticket into the Draw Barrel found at the Draw Location – Livewire 24/7 Sports Bar. The wristband must remain intact on the Eligible Entrant’s wrist until after the draw.</p> <p>If the Eligible Entrants cannot physically have the wristband attached around their wrist, the Eligible Entrants must immediately speak to the representative of the Promoter at the time of receiving the wristband and the representative of the Promoter will record: (1) the entry number on the wristband/Entry Ticket (“Entry Number”); and (2) the Eligible Entrant’s valid photographic identification (Passport or Australian driver’s licence). The Eligible Entrants must still detach the Entry Ticket from the wristband and place the Entry Ticket into the Draw Barrel found at the Draw Location.</p> <p>Entry Tickets can be placed into the Draw Barrel up to one (1) minute prior to the conclusion time (2:00PM).</p> <p>Each wristband will show a corresponding Entry Number to the detached Entry Ticket. At the time of the draw the Eligible Entrants must have a “Valid Wristband”, which means:</p> <ul style="list-style-type: none"> (a) a wristband that is intact on the Eligible Entrant’s wrist at the time of the draw; or (b) if the Eligible Entrants are unable to attach the wristband to the Eligible Entrant’s wrist, the Eligible Entrants must have provided their valid photographic identification (Passport or Australian driver’s licence) to the Promoter (as set out above) and that Eligible Entrants must be in possession of the wristband.
Item 7: Draw Details	<p>Draw will take place at: 2.15pm Saturday, 18 May 2024</p>

	<p>At each Prize Draw, two (2) Entry Tickets will be randomly drawn from the Draw Barrel at the 'Draw Location'. See Item 8.</p> <p>The Entry Number shown on the Entry Ticket will be announced at the Draw Location to find the Eligible Entrants with the Valid Wristband showing the correct corresponding Entry Number. ("Selected Winner").</p> <p>The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of Treasury Brisbane.</p> <p>The Selected Winners must be "present at the Draw" to be eligible to win a prize. If a Selected Winner is not "present at the Prize Draw", Item 9 will apply.</p> <p>Any drawn Entry Ticket will not be placed back into the Draw Barrel.</p> <p>Drawn Eligible Entrants that satisfy these conditions of entry in Item 5 and Item 9 and otherwise satisfy the Terms and Conditions will be deemed a "Selected Winner".</p>
Item 8: Draw Location	LiveWire 24/7 Sports Bar, Level 1, Treasury Brisbane
Item 9: Present at Draws	<p><u>"Present at the relevant Draw"</u></p> <p>The selected Eligible Entrants must present themselves to claim a prize. To be considered "present at the relevant Draw" and therefore eligible to claim a prize, Eligible Entrants must present themselves to a representative of the Promoter within three (3) minutes of their Entry Number being announced and provide the reciprocal Valid Wristband to the drawn Entry Ticket.</p> <p>If the Eligible Entrants have presented themselves to a representative of the Promoter, the representative will inform the promotions host at the Draw Location that the Eligible Entrants has presented themselves and the Eligible Entrants will have three (3) minutes to make their way to the Draw Location and confirm their identity. The Eligible Entrants are not permitted to send a proxy to claim a prize. The Promoter reserves the right in its absolute discretion to extend the time limit set out within this clause if the Promoter forms the reasonable view that the Eligible Entrants will be physically unable to comply with such time limit due to incapacity or any other such impairment. It is the responsibility of the Eligible Entrants to request such time extension from the representative of the Promoter before making their way to the Draw Location. Time Extensions will not be granted retrospectively.</p> <p><u>"Not present at the relevant Draw"</u></p> <p>If the selected Eligible Entrants are "not present at the relevant Draw" or does not otherwise satisfy these Terms and Conditions, redraws will take place until the Eligible Entrants who satisfies the requirements of these Terms and Conditions (including by being "present at the Draw") is drawn for each of the relevant Draws.</p>
Item 10: Prize/s	<p>Each Selected Winner that satisfies the conditions of entry, including being "present at the relevant Prize Draw," will win a 2024 team signed Broncos NRL Jersey of a random size selection. Noting that change of sizing can not be granted and the sizing of the Jersey is final.</p> <p>The total number of Jerseys is two (2), and total prize pool for the promotion period is \$3,000.00.</p>
Item 11: Identification	<p>A Winner may be asked to produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize.</p> <p>Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.</p> <p>The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a</p>

	representative of the Promoter without the assistance of these or any other form of identification.
Item 12: Other conditions	<p>Wristbands are only valid for Prize Draws on the Draw Day on which they are issued. The Draw Barrel will be emptied at the conclusion of each Draw Day.</p> <p>Removed, damaged or misplaced Wristbands may not be replaced.</p> <p>Any guest who has received more than one wristband on a promotion day, will be ineligible to take part in the promotion and cannot win a prize.</p>

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
 - e. not a director, officer, manager, employee or contractor of The Star Entertainment Group Limited or any of its related entities (including, the Promoter); and
 - f. not an immediate family member (including a sibling, parent, child, grandparent, grandchild, spouse, former spouse, de facto or former de facto partner, including a step-relation and an adoptive relation) of any person listed in item (f) above or of their spouse, former spouse, de facto partner or former de facto partner.
3. If an Eligible Entrants: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:
 - a. during the Promotion; or
 - b. prior to that person claiming the relevant prize (if the Eligible Entrants are a selected winner), so that he or she no longer satisfies **Condition 2**, that person will no longer be eligible to enter or participate in the Promotion and/or claim a prize (even if they are the selected winner) and that person will forfeit any entitlement to a prize.
- 3A. If, at the time of a draw, a person is restricted or prevented from entering the casino area due to a 'temporary prevention of entry' for contravention of a Playbreak rule, that person is not eligible to claim a prize (even if they are the selected winner) and that person will forfeit any entitlement to a prize.
4. Eligible Entrant's must earn Entries during the times listed in **Item 6** through the method listed in **Item 6**.
5. Draws will occur at the times listed in **Item 7** at the location listed in **Item 8**.
6. Eligible Entrant's must present at the draws in accordance with **Item 9** and produce identification in accordance with **Item 11**. If applicable the redraw mechanism is listed in **Item 9**.
7. The Prizes available in this Promotion are listed in **Item 10**
8. The Promoter reserves the right to refuse any person participation in the Promotion.
9. Directors, management and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the *Corporations Act 2001*) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises but is not limited to the businesses of The Star Sydney, The Star Gold Coast and Treasury Brisbane.
10. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the entrants claiming that prize.
11. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter.
12. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.

13. To the extent that a situation or issue arises for which these Terms and Conditions make no provision for or a situation or issue arises to which the relevant Terms and Conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these Terms and Conditions.
14. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
15. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
16. Any entrants who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
17. Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Entrant. The names of Entrants will not be published without their consent except as announced at the Draw Location.
18. Participation in the Promotion indicates acceptance of the Terms and Conditions governing the Promotion. These Terms and Conditions will be available at The Star Club Desk located at the participating properties of the Promoter throughout the Promotion Period.
19. The Promoter may need to collect your personal information (including Driver Licence number or Star Club Membership number) to provide the entrant with a wristband. The Promoter will use your personal information to conduct and manage the Promotion. By participating in this Promotion, each entrant's Entry/Entries becomes the property of the Promoter and may be used for the Promoter's business analysis and marketing purposes. The Promoter's privacy statement can be viewed at www.starentertainmentgroup.com.au/privacy-policy and includes the purposes for which The Star Entertainment Group, including the Promoter, may collect, store, use and disclose your personal information. Failure to supply the personal information requested or required by the Promoter may result in a wristband not being provided or an Entry being deemed invalid. Privacy law allows entrants to access their personal information held by the Promoter in certain circumstances.
