| Item 4: Promotion Period | The Promotion will commence at 12.45pm on Tuesday 2 March 2024 and will end at the conclusion of the 9.00pm session on Tuesday 30 April 2024. The “Promotion Period” All times are listed in Australian Eastern Standard Time (AEST) unless otherwise specified. |
| Item 5: Entry Requirement | Participation in the Promotion is open to all persons who: <ul style="list-style-type: none"> a) Are 18 years of age or older; b) Are entitled to access the Promotion Location (see Item 9); c) Not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); d) Not the subject of a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane; and e) are a Member of The Star Club or The Star Club Prestige Domestic or International programs operated by the Promoter and have a current membership card (each a “Membership Card”). <p>(Each an “Eligible Entrant”).</p> <p>People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as “Eligible Entrant/s” and will be entitled to enter the Promotion.</p> <p>The Promoter reserves the right to refuse any person participating in the Promotion at any time.</p> |

| Item 7: Method of Entry | Eligible Entrants must provide their Star Club Membership ID to register at the Draw Location to participate in the Promotion. Eligible Entrants will be allocated a session time in the order that they register. Eligible Entrants can register from 12:45pm each Promotion Day. Except on Thursday 25 April 2024, where eligible Entrants can register from 1.00pm. An Eligible Entrant may provide an alias for the First and Last Name if they wish, when registering. The top fifteen (15) placed Eligible Entrants will have their Star Club Membership ID, First & Last Name will be displayed on the Leaderboard found in the Promotion Location. |

No proxies may be used in place of the Eligible Entrant, unless it is determined by the Promoter that an Eligible Entrant is unable to participate without a proxy.

The Eligible Entrant, having presented a valid Membership Card to a representative of the Promoter, satisfying all entry conditions as per **Item 5**, and returning to their allocated Session. The Eligible Entrant will be allocated to an IGT Tournament Electronic Gaming Machine ("Device") by order of registration.

Should an Eligible Entrant not present to their allocated Session, they will forfeit their place in that Session and may not be allocated a new Session Time.

If the Promoter deems that any of the Devices are malfunctioning and requires removal from the Promotion, the Promoter reserves the right to remove the Device from the Promotion.

If an Eligible Entrant is unable to complete the specified period of play due to the removal of a Device, the Eligible Entrant will be provided with another one hundred and twenty (120) seconds of play on another allocated Device to determine that Eligible Entrant's Score (as applicable).

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
 2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
 - d. not the subject of a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:
 - (a) during the Promotion; or
 - (b) prior to that person claiming the relevant prize (if the Eligible Entrant is a selected winner),

 13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
 14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
 15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
 16. Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Entrant.
