The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as Treasury Brisbane, 159 William Street, Brisbane QLD 4001 ph. (07) 3306 8888 (the "Promoter").
Item 2: Promotion	Sovereign Barrel Draws – May 2024 (the "Promotion")
Item 3: Participating Property	Treasury Brisbane
Item 4: Promotion Period	The Promotion Period is from 7:00pm on Sunday 28 April until the conclusion of the 7.00pm draw on Sunday 26 May 2024. All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a selected Platinum, Diamond or Selected Prestige tier member of The Star Club with an active membership card (each an "Eligible Entrant"). For the avoidance of doubt, entrants who:
	 a. migrate to a higher membership tier during the Promotion Period will remain an "Eligible Entrant" so long as they: hold a Platinum, Diamond or selected Prestige tier The Star Club membership or higher for the duration of the Promotion Period, and have a valid Platinum, Diamond or selected Prestige tier The Star Club membership at the time of Entering the Promotion; relegate to a membership tier which is lower than Platinum tier The Star Club membership at any time during the Promotion Period, will be an "Invalid Entrant" and will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize.

	The Star Club Any Member found to be in breach of The Star Club Membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Members Membership Card, is subject to consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.
	Barrel Draws – Manual Entries It is at the discretion of the Promoter to issue manual Entries.

Terms and Conditions

- The Promoter listed in Item 1 will conduct the Promotion listed in Item 2 at the Participating Property listed in Item 3 during the Promotion Period listed in Item 4.
